GENERAL INFORMATION

ZnINC X-TREME® is recommended to correct zinc deficiencies. ZnINC X-TREME® should be used on the basis of a soil and/or tissue analysis.

DIRECTIONS FOR USE

Soil Application: Apply 1-2 qts. of ZnINC X-TREME® as needed. Formulated and compatible for all use in all liquid suspension fertilizers. Use recommended rates only from a soil or plant analysis where required by law.

Foliar Application: Apply 1-2 qts. of ZnINC X-TREME® as needed. Apply a minimum of 10 gallons of water per acre with the use of ZnINC X-TREME® to foliage with ground spray equipment.

MIXING INSTRUCTIONS:

1. Pour 1/3 water or fertilizer into tank
2. Add other pesticides*
3. Fill tank with balance of water or fertilizer
4. Add ZnINC X-TREME®
5. Agitate to assure proper mixing

*Caution: Check compatibility with orthophosphate fertilizers and other chemicals prior to mixing.

STORAGE AND DISPOSAL:
