# CORN:

Early vegetative stage: 16-32 oz. of SULFUR X-TREME® per acre. V3-V4 stage: 1-2 gt. of SULFUR X-TREME® per acre.

# COTTON:

4-5 node stage or 1st or 2nd glyphosate application: 1 pint of of SULFUR X-TREME® per acre. 9th node or after: 1-2 quart(s) of of SULFUR X-TREME® per acre.

# RICE:

Flag leaf: 1-2 quart(s) of of SULFUR X-TREME® per acre.

# SOYBEANS:

3rd to 4th triofoliate: 1 pint of of SULFUR X-TREME® per acre. Early Pod set: 1-2 quart(s) of of SULFUR X-TREME® per acre. WHEAT:

Dormancy break: 1-2 quart(s) of SULFUR X-TREME® per acre. STORAGE AND DISPOSAL:
