2. HAZARDS INDETIFICATION SUMMARY

KEEP OUT OF REACH OF CHILDREN - CAUTION - May cause eye and skin irritation. Avoid contact with skin, eyes, open cuts, and sores. In case of contact, flush with water. Get medical attention for eyes. This blended liquid fertilizer is derived from urea, iron EDTA, manganese EDTA, ammonium polyphosphate, and blackstrap molasses. Nausea and vomiting could be expected upon large dose ingestion. The acute ingestive effects are described as nausea, chills, and diarrhea. Eye and skin contact with these products could cause irritation (particularly in sensitive persons), and respiratory irritation could be expected from the unprotected inhalation of fertilizer mists. Product users should avoid prolonged or repeated skin contact by wearing impervious gloves, long sleeve shirt, long pants, socks and rubber boots. Goggles for eye protection are recommended. Wash thoroughly after handling and using this product.

This product is a black liquid with a bitter-sweet odor. Primary routes of entry are inhalation & eye contact. Skin absorption is unlikely to occur.
