This product is tank mix compatible with most fertilizers and pesticides. However due to the variability in water sources and pesticide formulations a compatibility test is recommended.

GENERAL USE RATES	
TURFGRASS: Warm and Cool Season	Apply 3 to 6 ounces per 1000 sq. feet as needed for maintenance. For deficiencies apply 8 to 12 ounces per 1000 sq. feet. Applications can be made every 7 to 15 days as needed for desired results.
ORNAMENTAL PLANTS AND TREES	Apply 1 to 2 quarts per 100 gallons of water every 30 days as needed

STORAGE AND DISPOSAL

Store in cool, dry place. Store in original container. Keep container tightly closed. Do not reuse empty container. Triple rinse, then offer for recycling or for disposal in a sanitary landfill, or by other means in accordance with local, state and federal regulations.
