# TURF EXCELLENCE™ ACE 0-0-29

This product is tank mix compatible with most fertilizers and pesticides. However due to the variability in water sources and pesticide formulations a compatibility test is recommended.

GENERAL USE RATES	
<b>TURFGRASS:</b> Warm and Cool Season	<b>GREENS and TEES:</b> Apply 2 to 8 ounces per 1000 square feet every 7 to 14 days as needed.  <b>FAIRWAYS, SPORTS TURF AND LAWNS:</b> Apply 1 to 3 gallons per acre every 7 - 21 days as needed.
<b>ORNAMENTAL PLANTS AND TREES</b>	Apply 2 to 6 quarts per 100 gallons of water foliarly every 14 to 21 days as needed. Apply 6 quarts per 100 gallons of water as a drench or in transplant water.
<b>FRUITS, NUTS AND VINE CROPS (Apples, Citrus, Grapes, Peaches, etc.)</b>	Apply 2 to 8 quarts per acre in 100 gallons of water beginning at first full leaf and/or fruit expansion. Apply at 30 day intervals up to harvest for improved sizing.
<b>SMALL FRUITS (Blackberries, Blueberries, and Strawberries)</b>	Apply 2 to 6 quarts per acre every 10 to 14 days starting before bloom.

DO NOT APPLY NEAR WATER, STORM DRAINS, OR DRAINAGE DITCHES. DO NOT APPLY IF HEAVY RAIN IS EXPECTED. APPLY THIS PRODUCT ONLY TO YOUR LAWN/GARDEN, AND SWEEP ANY PRODUCT THAT LANDS ON THE DRIVEWAY, SIDEWALK, OR STREET, BACK ONTO YOUR LAWN/GARDEN.
